I _____, am interested in the future of bowling in Memphis and am willing to devote my time and efforts for the betterment of bowling. I desire to have my name placed in nomination as requested for the Memphis Area USBC Association.

I recognize that, if elected, I will have the responsibility to attend all Board of Director meetings and to carry out any assigned duties to the best of my ability. Failure to meet these responsibilities will be cause for removal from office. Monthly Board of Director meetings are held on the second Tuesday of each month. Directors missing more than three meetings per year are subject to removal from office. I realize I must have the time to work as a lane representative and to work during the city or other tournaments.

I recognize that I must remain a member, in good standing, of the United States Bowling Congress. I must bowl in a league and/or reside within the jurisdiction of the Memphis Area USBC and MUST NOT bowl in any unsanctioned leagues.
