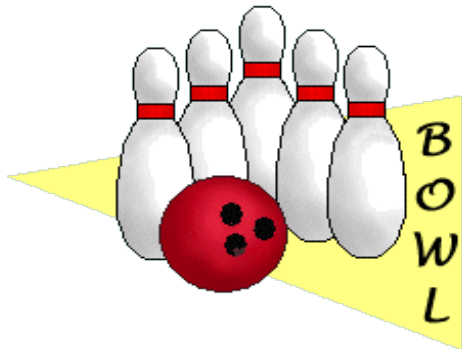

Memphis 600 Invitational Doubles Tournament Rules

- 1) A doubles team consisting of a current Memphis 600 club member and guest must be members of the Memphis Area USBC. Guest must not have previously rolled a certified 600 series.
- 2) Entries will close one hour prior to tournament start time.
- 3) This tournament is certified by USBC and will be a three game doubles event. Bowlers will be assigned lanes as completed entry and all fees are paid. Entry fees may be paid by cash or check payable to Memphis 600 Club. A \$30.00 fee will be charged for any returned checks.
- 4) This tournament will be conducted on a handicap basis – 90% of the difference of the entrant's highest USBC 2013-2014 average and 220.
- 5) Entrants will use their highest USBC 2013-2014 season certified average of at least 21 games. Bowlers with no 2013-2014 average will use their 2014 summer league average or current league average as of 21 games, whichever is highest. League standing sheets must be provided for verification. All others will bowl with an assigned 220 average.
- 6) It shall be each bowler's responsibility to verify the accuracy of her average. Failure to use the correct average shall disqualify scores if submitted average is lower than correct average. Corrections in average can be made up to the start of competition.
- 7) USBC Rule 319a-2 (10 pin increase provision) and 319e (15 pin increase provision) will be waived.
- 8) USBC Rule 319d (Reporting of Prize Winnings) will not apply.
- 9) All prize money will be returned 100%. Prize ratio will be at least one prize for each five entries.
- 10) In the event of a first place tie, co-champions will be declared and prize money will be combined and divided equally.
- 11) Pacers are NOT permitted.
- 12) In the event a bowler cannot finish her series, zero pins will be scored on the remaining frames.
- 13) Bowlers may check in one (1) hour prior to tournament start time, presenting USBC membership and National 600 membership cards.
- 14) Prize money will be mailed within thirty (30) days after the conclusion of the tournament.
- 15) USBC rules and regulations shall govern this tournament.
- 16) All cell phones must be either turned off or placed in silent or vibrate mode during meeting and tournament. No electronics may be used while participating in this tournament.
